



RegPol² National Workshop in the Czech Republic

Event Description

MEPCO, a joint venture of the Union of Towns and Municipalities of the Czech Republic and Dutch VNG International, seeks to share preliminary findings and gain feedback from municipal and regional actors on on-going research within the Marie Curie Action ITN RegPol² (www.regpol2.eu) on the theme of regional polarisation and peripheralisation in Central and Eastern Europe.

The seminar will consist of two thematic panels joining RegPol2 fellows conducting research in the Czech Republic with local researchers, experts and practitioners in regional development, planning and public administration, including participants from the Ministry of Regional Development, Ministry of Interior and SMO. Each panel will be followed by an open discussion period.

The thematic issues to be discussed in the panels are:

- 1. Intermunicipal and cross-border cooperation;
- 2. Issues of regional policy and multi-Level governance: from EU to local level

The event is open to a range of regional policy stakeholders, nevertheless targeted towards an audience of approximately 40 municipal and regional actors – policymakers and practitioners concerned with regional development and EU programming – who can provide practical feedback to researchers.

The event will be held in English without translation. Light refreshments will be served.


